

## Terms of Use

PLEASE READ THESE TERMS OF USE (“AGREEMENT” OR “TERMS OF USE”) CAREFULLY BEFORE USING THE SERVICES OFFERED BY DENARIUS CAPITAL ADVISORS, INC. (dba Money Intelligence) (“COMPANY”). THIS AGREEMENT SETS FORTH THE LEGALLY BINDING TERMS AND CONDITIONS FOR YOUR USE OF THE VARIOUS WEBSITES OWNED AND OPERATED BY COMPANY, INCLUDING, WITHOUT LIMITATION, THE WWW.MONEYINTEL.COM WEBSITE AND DOMAIN NAME (“SITES”), AND ANY OTHER FEATURES, CONTENT, OR APPLICATIONS OFFERED FROM TIME TO TIME IN CONNECTION THEREWITH (COLLECTIVELY, THE “SERVICE”). BY USING THE SITES OR SERVICE IN ANY MANNER, INCLUDING BUT NOT LIMITED TO VISITING OR BROWSING THE SITES, YOU AGREE TO BE BOUND BY THIS AGREEMENT. ### **Acceptance of Terms:**

The Service is offered subject to acceptance without modification of these Terms of Use and all other operating rules, policies and procedures that may be published from time to time on the Sites by Company. If Client received such information less than forty-eight (48) hours prior to entering into this Agreement, this Agreement may be terminated by Client without penalty within five (5) business days from the Effective Date. On written request by Client, DCA agrees to annually deliver electronically, without charge, DCA's brochure required by the Advisers Act.

Client agrees to receive from DCA other notices and updates, to DCA's brochure, Privacy Policy, and other required disclosures and statement, electronically or through the Site.

**Registration:**

As a condition to using certain aspects of the Service, you will be required to register with Company with a valid email address ("Company User ID") and select a password. You shall provide Company with
